## Greetings from Susan

Hello to All!

It is with great excitement that I send this second "Poll Worker" correspondence to you. I have waited until now to send this to you because of the uncertainty of things in Tallahassee. Well, now is the time! The Governor and the legislature have finalized this year's changes.

I want you all to have a great summer. As I told you earlier, we are definitely going to start early preparing for the 2008 elections. I know you have heard from the newspaper or TV, that the governor and legislature changed the dates for the 2008 elections, so here they are:

PRESIDENTIAL PREFERENCE PRIMARY—JANUARY 29, 2008 TUESDAY
PRIMARY—AUGUST 26, 2008—TUESDAY

GENERAL-NOVEMBER 4, 2008-TUESDAY

PLEASE MARK YOUR CALENDAR NOW, and start making plans to work and train. I informed you last year that, since 2000 things are constantly changing in the election process. You must now consider yourselves employees of the elections' office, and not just election day poll workers. This means that we need you to work all the elections and attend all training scheduled between now and the last election of 2008. If you work the Presidential Preference Primary in January, we expect you to work them all and attend all training. If the elections office invests in the training of our workers, we depend on you to work, or if you are a substitute, work when called to duty. Gone are the days when you could work an election and not attend a school, or you worked one election and not the second, et cetera. Laws and situations have changed drastically. We need you to attend all schools to keep you informed of changes on both laws and procedures. Also, to rehash procedures which have not been changed. We all know that, we learn best when we practice, practice,

#### New in 2008:

Below are parts of the 2008 Legislative Session changes from CS/HB 537 that will affect your work at the polls. The Governor signed this bill on May 21, 2007.

- Effective July 1, 2008- all voting shall be mark-sense, using a marking device. This means that
  we go back to paper ballot, optical scan voting. The touch screen will only be used for voters
  with disabilities. Note: by 2012 all voters will be using a form of paper ballot, even those with
  disabilities. (new 101.56075FS)
- 2. Effective May 21, 2007—A minor party could have their own ballot in a primary election if they have their own candidate qualify. Just like the Democrats and Republicans and Nonpartisans have their own. (new 99.096FS)
- 3. Effective January 1, 2008– Removes two forms of ID that an elector may use at a polling location for identification: (1) employee badge or identification (2) buyer's club identification.

## TRAINING FOR THE PRESIDENTIAL PREFERENCE PRIMARY ELECTION

August 15, 2007 through September 28, 2007

## November 19, 2007 through December 21, 2007

We are conducting the first of the training sessions for the 2008 election year, beginning in August and it will go through September. Each training school will be conducted at the polling site in which you worked last election or will work for 2008, or where you may be a substitute. You will soon be contacted by your clerk as to the exact date at your polling place (site). If for some reason you cannot attend your polling place school (training), please tell your clerk as soon as you know and then contact Jennifer in the Elections' Office, so that she can place you into another place (site). Remember, it is very imperative that you attend one of these training sessions. Since the Presidential Preference Primary has been moved to January 29, 2008, we will only have time and money to have one more training session for the January election. Those dates will begin in November and go through December, with two scheduled for each day and one day with three scheduled. This way, we are all through with training before Christmas, and the Elections' Office will be able to meet all our deadlines for the January 29th election date.

I am so sorry that we have to ask each of you to give up vacation days during this holiday season, but the legislature has set the date and we must do our duties to get the job done. I would like to thank you all in advance, and say I am so grateful to you for wanting to work through this particular time in the election process. Thank you, Thank you!

If you <u>cannot work</u>, then we understand, and will miss you. But, please, <u>call Jennifer or your clerk as soon as possible if you CANNOT WORK for 2008. Also, please fill out the attached "Are You Working in 2008?" information and return IMMEDIATELY.</u>

## TRAINING FOR THE PRIMARY ELECTION

## July 7, 2008 through July 30, 2008

I have also set the dates for the Primary and General election training. Please mark these dates as well. Again, your clerk will call you and let you know when to attend. When it gets close to the date for your particular school, and you have an emergency situation and cannot attend your scheduled class, again, you must call your clerk to let him/her know and then call Jennifer in the Elections' Office so she can schedule you for another class.

The Primary school dates will begin July 7th and go through July 30th, **2008.** We are in the process of scheduling the 2008 election schedule with each polling site. Once the Elections' Office has all times and dates confirmed and the polling site has everything on their calendar, Jennifer will begin to call each clerk with the information so that the clerks can call their workers. **Clerks, it will be very important for you to contact your workers immediately** so they can put these dates on their calendar, or if they are unable to work, they can let us know now, so we can begin to search for new poll workers to take their place.

## TRAINING FOR THE GENERAL ELECTION

#### **September 15, 2008**

This training school will be set on one day, with three sessions. Clerks and Assistant Clerks must attend at least 3 hours of training; Inspectors and Deputies must attend at least 2 hours of training. We will have our "live training" on sensitivity during the first hour of each session. The site for these sessions has not been determined as of this date. We should be in our new office by then and the board of county commission's meeting room should be finished, if there is enough space in the new board meeting room, we could possibly have it there. I will have all sessions at a Palatka location, for it will be hard for me, my staff and the people who must demonstrate the sensitivity, to travel to other sites in just one day.

## RECIPES

## Easy Apple Dumplings

1 (8 oz.) can crescent rolls

2 cooking apples

2/3 c. sugar

3/4 c. water

1/2 tsp. cinnamon

1 tsp. vanilla

Peel, core and quarter the apples. Wrap apple quarters in one crescent triangle. Place 8 wrapped sections in a 9-inch glass dish. Heat remaining ingredients until sugar dissolves. Carefully pour over apple dumplings.

Bake at 375 degrees for 30-35 minutes. Let stand for 10 minutes. Serve with Cool Whip or ice cream.

## **Provisional Ballots**

Attention Poll Workers: Please cut out the following reasons for a provisional ballot (or keep this letter) and study them. This will be on the test we give you. We want <u>all</u> of you to be familiar with the reasons for a provisional ballot before election day:

- 1. Voter's name does not appear on the precinct register and voter's eligibility cannot be verified.
- 2. Voter refutes the supervisor's office confirmation that he or she is not registered/eligible.
- 3. There is an indication on the precinct register that the voter has requested an absentee ballot and the voter does not have a ballot to surrender. Poll worker cannot verify that the voter has not voted.
- 4. There is an indication on the precinct register that the voter has returned the absentee ballot or has voted in the office or at an early voting site, but the voter maintains that he or she has not voted, even after a call to the office.
- 5. Voter did not provide picture and signature identification.
- 6. There is an indication on the precinct register that the voter has been challenged in this election.
- 7. Voter is challenged at the precinct (attach copy of challenge—do not enclose oath in envelope)
- 8. Voter's ID signature and signature given do not match. Voter refused affidavit.
- 9. Indication on precinct register that voter's status is pending because FL DL#, FL ID card# or SSN is not yet verified by the state.
- 10. Other (provide comment)
- 11. Extended hours at Polls, after 7 PM.

## We Remember.....

We regret to announce the passing of two members of our poll worker family.

Edwin Cox, clerk at 1st Presbyterian Westminster Hall, passed away on Tuesday, January 30, 2007. Mr. Cox was born in Terra Haute, Ind., in 1939. In 1957, he graduated from Edgewater High School in Orlando and, after eight years active duty in the USAF, went on to earn a bachelor of science degree from the University of Florida in Gainesville. While a student at the university, he was the general manager of Alachua Ambulance Service.

He entered the U.S. Army Reserve and served an additional 16 years before retiring as a master sergeant. His 18 awards included the Combat Aircrew Badge, Armed Forces Expeditionary Medal, National Defense Service Medal, Combat Readiness Medal and the Expert Marksman Badge (rifle and pistol). He logged over 3,200 flying hours while on active duty as a radar operator on board the EC-121D Radar Pickett aircraft during and after the Cuban Missile Crisis, as well as on missions in and around several other countries.



During his working years, he was employed in Tallahassee by the Florida Department of Agriculture & Consumer Services as the coordinator for the Florida Agricultural Advisory Council, in Tampa by the Florida Poultry Federation as executive vice president and, finally, in Atlanta by the U.S. Poultry & Egg Association as vice president-expositions, before retiring in June 2001. He became a poll worker for the 2004 Primary Election, and clerk for the General. He worked in Early Voting for the 2006 election cycle and helped with extra training on the touch screens.. Mr. Cox was a great worker and friend. He will be greatly missed by all who knew him.

Jean Messina, inspector at Putnam County Agricultural Center, passed away on December 5, 2006. She was 80 years young. Ms. Messina lived in East Palatka and was formerly from Jacksonville Beach and Keystone Heights. In Keystone Heights she and her late husband Nick Messina owned an audio & visual store. She lived there 15 years before moving to Putnam County 4 years ago. Jean enjoyed time with her family, playing bridge, laughing and volunteering in any capacity that would help others.
