## Payroll Changes

Starting with the Customer Services Classes in April, our office has decided to go with Westaff for poll worker payroll. You will be officially employed by Westaff, but still work with the elections' office. You will still deal with our office on every other matter except for pay checks. ***If you did not attend classes in April, you need to go by Westaff at 436 N. Highway 17 Suite 1 and pick up an application to fill out so they can input your information into their computer as soon as possible.*** Our hope is that after the elections, your check will get to you faster with someone outside the office handling your payroll. After elections, we have so many deadlines, and only 6 people in our office to do the work to meet them. To have payroll for approximately 280 poll workers on top of everything else is a difficult task. The checks for April took a little longer due to Westaff having to input everyone's information into their system for the first time. As always, adjusting to a change after you are used to things being done a certain way will take some time. We will get everything set for the Primary Election in August. Below you will find a review of the pay rates. There was some confusion because the check stubs showed you were paid for one hour, however, we don't pay by the hour. That is how they had to set things up in their computer. Please review the pay rates so there will be no confusion the next time.



***Clerk - \$130.00***

***Assistant Clerk - \$120.00***

***Inspector - \$115.00***

***Deputy - \$115.00***

***All positions get paid \$15.00 per CLASS. Not by the hour.***

***Also, if you ask to come in the office for extra training, we are more than glad to provide you the opportunity.***

***However, you will not be paid for self initiated training.***

## *Thank You State Legislators*

**A GREAT BIG THANK YOU TO STATE LEGISLATORS**

For voting to postpone the replacement of the touch screen units from 2012 to 2016.

For the past two years the Florida Supervisors of Elections have worked hard to persuade the Florida House and Senate to agree to postpone the requirement set by law in 2006, that by 2012, all counties would have to replace the touch screen units used voters with a disability. Our reasons for postponement were many, here are a few: because there were no funds available anywhere to purchase the equipment; the only equipment on the market to fill the bill was not fully acceptable by those with disabilities who would be using it; and, there was not enough time to purchase, receive the equipment, get staff trained and have the staff train the poll workers. We have finally succeeded in having our voice heard, as both the house and senate agreed to vote for a bill postponing the change until 2016. Now all we are doing is waiting for the Governor to sign the bill, or allow the bill to become law without his signature. Let’s all hope that it becomes law now.
